Sub: Resentment against non-settlement of demands.

Res Sir,

A meeting of our Circle Union Secretariat was convened at Bhopal on 23.02.2017 wherein various demands taken up by our union with Circle management were discussed and all our office bearers expressed their anguish and disappointment on the inordinate delay in resolving the issues. It was decided to remind management to settle the old issues and issues developed recently before 19.03.2017 i.e. date of our CEC being held at Satna, The issues are as below.

- 1 Kindly refer OUR AGITATION NOTICE no. BSNLEU/ MP CIRCLE / AGITATION /1 DATED 19.09.2016.consisting of 8 point agenda. A meeting to discuss the issues was held on 10.10.2016 headed by you with our delegation and believing the assurances we deferred our agitation program. I am constrained to inform you that issues are not resolved till date resulting in resentment amongst leaders & members.
- 2 Non-settlement of the Burning problems and unpleasant situation developed in Satna and Sagar may harm the industrial peace in circle. The SSA Heads are not interested in curbing the bitterness being developed at both places. Your immediate intervention is must to resolve the issues in an amicable manner. Detailed letters citing the cause of resentment have already been given earlier.
- 3 Our DS of Jabalpur has unearthed a case of corruption in compassionate appointment before some months. It is unfortunate that instead of probing the case, Jabalpur Management is trying to implicate the complainant in the corruption. This is an act of vengeance by the management against the whistle blower. This is not acceptable. Intervene suitably.
- 4.It is very painful to note that EPF amount in r/o Shri Manoj Sharma is not deposited by the management till date.. Number of letters have been exchanged between union, official and the management in this regard. A declaration by the official as discussed with you has also been submitted. But some of your subordinates are again creating hurdles in the process of deposit of EPF. kindly order to Expedite.

Sir, it has been decided in our Circle Union Secretariat meeting to discuss the above matter at length in our CEC on 19.03.2017 at Satna and the future course of Trade Union Action will be decided and implemented according to the directives of CEC if the long pending issues are not resolved soon.

Hope, Circle Management will gear up soon for an amicable solution to all the problems.
