**Res Sir,**

Kindly peruse our Union's Letter No. BSNLEU/ MP CIRCLE /AGITATION/ 1 DATED 19.09.2016, Letter No. BSNLEU/ MP CIRCLE /AGITATION/ 2 DATED 28.02.2017 AND Letter No. BSNLEU/ MP CIRCLE /AGITATION/ 3 DATED 06.04.2017

I am constrained to inform you that no satisfactory action is taken by the Management on the demands & issues raised by us. Reply given to us vide your letter No SR-67/Union/Reco./Main/BSNLEU/Ch-II/2016-17/59 dated 5.5.17 is not convincing and is nothing but **Old Wine in New Bottle.** Even the decisions taken in the meetings held with you and your subordinates are not being honoured. Despite clarification, EPF case is not being finalized. WTP staff is threatened of transfer. Lack of amenities & cleanliness is a big issue. One of your SSA Head is promoting the fights amongst unions using "Transfer" as a tool disregarding the transfer policy. He is in habit of doing so.

To add fuel to fire , instead of settling the demands, management is provoking us by involving our innocent leaders in fake cases & by issuing transfer orders of the staff in circle office while Rule 8 transfers are pending. This action of the management will not deter us and we will keep opposing the wrongs/misdeeds in the system and lethargy in the revival process by some of SSA Heads.

**The apathy of Circle Management towards resolving the genuine problems has left us with no alternative but to resort to trade union action. Our Agitation Program is as below.**
