- 6. In the annexure-I date of death/retirement on medical ground/missing of employee is given. However the said date must be checked & verified from your office record, before issuing appointment order.
- 7. If any candidate refuses to accept the offer of Group 'D' post a refusal may be obtained and copy of the same duly attested by Head of SSA may be forwarded to this office immediately.
- 8. If Group 'D' posts are not vacant in concerned SSA to accommodate these applicant the same may be intimated to this office immediately.
