This has the reference of your letter under reference on the subject matter it is to bring your information that the cashless medical facility was started for the welfare of the employees however it is brought to the notice of BSNL management that facility is being misused and without need officials were admitted in hospital for indoor treatment in various SSA, consequentially increment of medical expenditure.

Cashless medical facility was discontinued for the intention of curtailment of expenditure and for ensuring admission in the hospital only on the inevitability basis. Due to which very positive outcome are obtained.

Since, by reason of this needy employees had suffered a lot due to above reason and there was a demand to restart the facility from your union also, hence, after detailed discussion, it has been decided to restore cashless facility for one or two hospital empanelled in each B.A./ SSA having transparent and fair billing as well as treatment.

Further, in this context, all B.A.s/ SSAs have already been requested vide letter on dated 10.07.2018. (Copy enclosed) for submission of names of hospitals for restoring cashless facility.

Sub: Restoration of Cashless Facility in M.P. Telecom Circle.

Kindly refer this office letter dated 27.03.2018 vide which cashless facility in M.P. Telecom Circle was withdrawn w.e.f. 01.04.2018 due to exuberantly high medical bill resulting excessive expenditure in Indoor Medical Treatment. During the course of discussion, the CS of Unions/Associations and individual employees have requested for restoration of cashless medical facility for the selected hospitals in M.P. Circle as the employees are facing hardship in their Indoor medical treatment. To avoid the hardship to the employees, it has been decided that cashless medical facility will be restored to one or two selected hospitals in each BAs having transparent and fair medical treatment/billing for limited period. It has also been decided that one hospital may be restored in cashless facility in each SSA on similar conditions/ground.

In view of above, all BA/SSA Heads are requested that the name of one or two hospitals having transparent and fair medical treatment/billing may kindly be intimated to this Office for restoration of cashless facility for such hospital please. An immediate necessary action in the matter is requested.
