सेक्रेटरी, टेलीकॉम और AUAB के बीच आज **02.12.2018** को चर्चा हुई। चर्चा में यह परिलक्षित हुआ कि 4G स्पेक्ट्रम का आवंटन, पेंशन रिवीजन और गवर्नमेंट के नियम के अनुसार पेंशन कॉन्ट्रिब्यूशन के भुगतान के मुद्दे पर प्रगति हुई है। लेकिन 3rd PRC के मुद्दे पर गतिरोध बना हुआ है। सेक्रेटरी, टेलीकॉम द्वारा इस मुद्दे की स्थिति पर दिए गए जवाब से AUAB सहमत (कन्वेंस) नहीं है।

ऐसी परिस्थिति में माननीय संचार राज्य मंत्री से चर्चा के एक और अवसर की सुनिश्चितता के मद्दे नज़र AUAB ने अनिश्चितकालीन हड़ताल को एक सप्ताह के लिए स्थगित करने का निर्णय लिया है। माननीय संचार राज्य मंत्री से मीटिंग में हमारे मुद्दों पर अपेक्षानुरूप निर्णय न होने की स्थिति में अनिश्चितकालीन हड़ताल **10.12.2018** को 00.00 hrs से पुनः शुरू होगी।






