Subject:- Board level and below Board level posts including non-unionised supervisors in Central Public Sector Enterprises (CPSEs)- Revision of scales of pay w.e.f. 01.01.2007 – Payment of IDA at revised rates-regarding.

In modification of this Department's O.M. of even No. dated 02.04.2019, the rate of DA payable to the executives and non-unionized supervisors of CPSEs (2007 pay revision) is as follows:

a) **Date from which payable:** 01.07.2019

b) **Average AICPI (2001=100) for the quarter March, 2019 – May, 2019**

March 2019	309
April, 2019	312
May, 2019	314
Average of the quarter	311.67


c) **Link Point:** 126.33 (as on 01.01.2007)

d) **Increase over link point:** 185.34 (311.67 minus 126.33)

e) **DA Rate w.e.f. 01.07.2019:** 146.7% [(185.34 ÷ 126.33) x 100]

2. The above rate of DA i.e. 146.7% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.Ms. dated 26.11.2008, 09.02.2009 & 02.04.2009.

3. All administrative Ministries/ Departments of the Government of India are requested to bring the foregoings to the notice of the CPSEs under their administrative control for necessary action at their end.
